## §170.315(b)(10) Electronic Health Information Export Overview

VSS Medical Technologies, Inc.'s Aura Sigmund and MeicFusion ERX supports a single patient electronic health information export as well as a patient population electronic health information export in compliance with §170.315(b)(10) Electronic Health Information Export. Some electronic health information might not be available in a table format (CSV), such as rich text documents or images,

- Single Patient Export can be generated by users with security access rights at any time without developer assistance.
- Patient Population Export can be generated with developer's assistance by contacting Support.

Please see the designated sections of this document for additional information.

Electronic Health Information (EHI) as defined by HealthIT.gov refers to "electronic protected health information" (ePHI) to the extent that it would be included in a designated record set as defined in 45 CFR 164.501. EHI does not include psychotherapy notes as defined in 45 CFR 164.501 or information compiled in reasonable anticipation of, or for use in, a civil, criminal, or administrative action or proceeding. The EHI definition represents the same ePHI that an individual would have the right to access under the HIPAA Privacy Rule (For additional information about the definition of EHI, we refer readers to the Understanding Electronic Health Information (EHI) fact sheet).

## §170.315(b)(10) Electronic Health Information Export – Single Patient

#### Security:

Screen Rights – Clinical / Client C-CDA 2.1 MU3 (Web) Screen Rights – Clinical / Document Imaging Screen Rights - Billing / Transaction Ledger Reports – all reports noted below are controlled by Security. Optional Right – Multiple Screens / Allow to print document even though it is suppressed.

#### Access:

- Reports are accessed by navigating to Reporting by clicking Reporting from the Username Menu. Reports can be run individually or by creating a Report Bundle.
- C-CDA is accessed by navigating to Client Chart and clicking CCDA button.
- C-CDA export is accessed by navigating to Data Export by clicking Data Export from the Username Menu.

- Some electronic health information might not be available in a table format, such as rich text documents or images.

#### Access:

- Contact Support for assistance in generating a patient population export.
- Reports are accessed by navigating to Reporting by clicking Reporting from the Username Menu. Reports can be run individually or by creating a Report Bundle.
- C-CDA is accessed by navigating to Client Chart and clicking CCDA button.
- C-CDA export is accessed by navigating to Data Export by clicking Data Export from the Username Menu.
- Imaging requires assistance from support to export patient population.
- Remittance requires assistance from support to export patient population.
